


NOTE:
 Block "P", 3 - Rm - 83 has no bearings. Deeds D1, D2, D3, and many others, have the sidelines of Lots 3, 4 & 5 at right angles to King Street. Extensive calculations confirm the sideline bearing of N 12°07' E as shown on R3 which conforms with occupation in the block. This survey revises the lines shown on R6 to reflect this bearing.
 The residence on the Lands of Rogers burned down and was rebuilt which resulted in the loss of many of the monuments shown on R6.
